Maharaja Agrasen College has formally constituted an Anti-Defacement/Proctorial Committee to inquire into all incidents of defacements. On receipt of an oral or written complaint against the student in such case, the student may be liable to pay fine Rs. 25.000/- or as decided by the College or be suspended from the college or be rusticated from the college for a specified period and may also be debarred from contesting election according to the relevant rules of the University/other applicable laws.
