Duly filled and signed Price Bid (Annexure – 3) along with signed Tender Documents should be submitted in a sealed envelope to The Principal, Maharaja Agrasen College, University of Delhi, Vasundhara Enclave, Delhi-110096.

'Tender Enquiry for Appointing of Consultant for establishing Media Lab' should be written on the top of the sealed envelope. Last Date of submission of the bid is 05.03.2021 (upto 12.00 noon) and the bid opening time is 05.03.2021 at 04.00 p.m.

The bidders are requested to read all the documents carefully (including annexures) and put their signature in each page of the Tender Document & Price Bid towards acceptance of the Scope of works, Terms and Conditions, Price Offer etc.

The bidder has to provide work contract of their successful project/s of the same nature in the bid document and arrange physical visit to the same project before opening of the bid. Satisfactory report from the committee/department is an essential qualification for consideration of the bid. Please refer to Annexure – 2 for details and other terms & conditions.

QUALIFICATION CRITERIA FOR CONSULTANCY WORK

Guidance and Assisting in the Process of Establishment of Media Lab

A. Minimum Requirement for the bidder

- 1. Consultant/Firm should have at least five years of experience in Broadcast Media (Attach Proof).
- 2. Consultant/Firm should have carried out such work successfully in Media Industry or in Academic Institutions (Attach Proof).
- 3. Consultant/Firm should preferably be based at Delhi / NCR or should have Branch operating from Delhi / NCR (Attach Proof).
- 4. Consultant/ Firm should possess their own human/material/ technical resources for carryout the task (Attach Proof).

B. Scope of Consultancy Work

Scope of work for consultant for establishment of media lab (a AV Studio including PCR and a PO Booth cum Audio recording studio)

- 1. Conduct GAP analysis on existing systems and facilities available in Media Lab
- 2. Provide guidance and estimate for the establishment and commissioning of Media Lab.
- 3. Preparation of specifications of equipment, layout and procedural documents etc.
- 4. Periodic review of the progress of work to be submitted with the authority and suggest corrective action, if any.
- 5. Monitoring of installation and final handover.
- 6. Total duration for consultancy should be 3 months or till the date of final lab establishment whichever is later.
- 7. Unsatisfactory performance by Consultant/ Firm will lead to termination of contract & forfeiture of balance payment.
