#### **Office Order**

## Sub.: Special Cash Package Equivalent in lieu of Leave Travel Concession Fare for Central Government Employees during the Block Year 2018-21

The Department of Expenditure, Ministry of Finance, Govt. of India, vide OM No. 12(2)/2020-EII (A) dated 12.10.2020 has issued orders towards reimbursement of cash equivalent of LTC, comprising Leave Encashment and LTC, if an employee opts for this of one LTC in the Block of 2018-21 subject to the conditions, as contained in the aforesaid OM and subsequent FAQs dated 20.10.2020, 10.11.2020 and 25.11.2020 on the above cited subject.

Further, University of Delhi vide Notification No. Estab. II (i)/2012/39/944 dated 19.11.2020 has also endorsed the above said OM.

Accordingly, college is in receipt of applications from a number of employees. In this context, all concerned are hereby informed that the college is not in a position to entertain all such request/claims, due to non-release of sufficient funds by the funding agency. Further, those employees who wish to avail aforesaid special cash package may make the purchases/avail services, as per the provisions of above said OM and FAQs, and submit their reimbursement claims to the Administration. The payment will be done on receipt of sufficient funds from the funding agency. In case sufficient funds are not released by the funding agency during the current financial year up to 31.03.2021, all such claims/reimbursement shall be forfeited, as the said orders are effective from 12.10.2020 and will be in force during the current financial year till 31<sup>st</sup> March, 2021.

It is once again reiterated, that claims shall only be reimbursed if sufficient funds are released by the funding agency and the purchases made/services are as Jusalini per the provisions contained in the above said OM and FAQs. -
